COOKIES POLICY BRIEF

Who are we and what do we do with your personal data?

LM INDUSTRY s.r.l., henceforth the Data Controller, protects the confidentiality of your personal data and guarantees the necessary protection from any event that could put them at risk of breach.

For this purpose, the Controller implements policies and practices concerning the collection and use of personal data and the exercise of the rights that are recognised by the applicable legislation. The Data Controller is responsible for updating the policies and practices adopted for the protection of personal data whenever this becomes necessary and however in the event of regulatory and organisational changes that may affect the processing of your personal data.

How does LM INDUSTRY s.r.l. collect and process your data?

The Controller collects and/or receives information about you, such as: IP address and cookies issued through navigation of the site http://lm-industry.com/ which are required by the Controller for the management of the site and to collect aggregate information. The communication of your personal data occurs mainly to third parties and/or recipients whose activity is necessary for the performance of activities related to the aforementioned purposes, and also to meet certain legal or prescribed obligations for the control and supervision of the business. Any communication not made for these purposes will require your consent.

Your personal data will in no way be disseminated or disclosed to indeterminate parties.

What are cookies and for what purposes can they be used

A "cookie" is a small text file created by some web sites on the user's computer when he/she accesses a certain site, with the purpose of storing and transporting information. Cookies are sent by a web server (which is the computer on which the visited website is running) to the user's browser (Internet Explorer, Mozilla Firefox, Google Chrome, etc.) and stored on the computer of the latter; they are then sent back to the website on subsequent visits.

Some operations cannot be performed without the use of cookies, which, in some cases, are therefore technically necessary. In other cases, the site uses cookies to facilitate navigation by the user or to allow them to take advantage of specifically requested services.

Cookies can remain in the system even for long periods and can also contain a unique identification code. This allows the sites that use them to keep track of the user's navigation within the site itself, for statistical or advertising purposes, to create a personalised user profile from the pages that the user has visited and to show and/or send him/her targeted advertising (so called Behavioural Advertising).

Which cookies are used and for which main purpose

This site uses different types of technical cookies, but not profiling cookies.

The Controller indicates below the specific categories of cookies used, the purpose and the consequences that derive from disabling them:

Third-party cookies

Third-party cookies, i.e. cookies created by a website other than the one the user is currently visiting, are operating on this website.

The Controller is obliged to provide the updated link to the information and consent forms of the third parties with which special agreements have been made for the installation of cookies through its site.

In particular, users are informed that the website uses the following services that issue cookies:

- The "Google Analytics" web analysis service provided by Google, Inc. Google Analytics is a web analysis service that uses "cookies" that are stored on the user's computer to allow the website visited to analyse how users use it. The information generated by the cookie about the use of the website visited by the user (including the IP address) will be transmitted to Google, and deposited on Google's servers in the United States. Google will use this information for the purpose of tracking and reviewing the use of the website by the user, compiling reports on website activity for website operators and providing other services relating to website activity and Internet usage. Social buttons

On the site http://lm-industry.com/ there are some special "buttons" (called "social buttons/widgets") showing the icons of social networks (e.g. Linkedln). These buttons allow users browsing on the sites to interact with a "click" directly with the social networks shown there. In this case, the social network acquires data relating to the user's visit, while the Controller will

not share anynavigation information or user data acquired through its site with social networks accessible via the Social buttons/widgets.

Disabling and enabling cookies

By accessing the site and following the initial banner containing the brief policy, the user has given his/her express consent to the use of the aforementioned third-party cookies.

Individual cookies can be enabled/disabled freely through the user's browser (by selecting the settings menu, clicking on Internet options, opening the privacy tab and choosing the desired cookie blocking level). For more information, see the following links: Google Chrome, Mozilla Firefox, Apple Safari and Microsoft Windows Explorer.

Furthermore, the Do Not Track option can be enabled in most of the latest generation browsers.

Third-party cookies can be disabled through information provided in the third party privacy policy, via the link above, or by contacting the third party directly. The disabling of "third-party" cookies does not affect navigation in any way.

Secondary purposes:

1. communication to third parties and recipients

The processing of your personal data occurs in accordance with the contract and legal and/or regulatory obligations deriving therefrom.

Your data will not be disclosed to third parties/recipients for their own purposes unless:

- 1. you provide authorisation;
- 2. it is necessary for the fulfilment of the obligations arising from the contract and by the laws that govern it (e.g. for the defence of your rights, etc.);

The personal data that the Controller processes for this purpose, include:

- IP address and cookies issued during navigation
- name and surname, telephone number, e-mail

2. Computer security

The Controller processes, also through its suppliers (third parties and/or recipients), your personal, computer (e.g. logical access) or traffic data collected or obtained in the case of services displayed on the website to the extent that is strictly necessary and proportionate to ensure the security and ability of a network or servers connected to it to withstand, at a given level of security, unforeseen events or illicit or malicious actions that compromise the availability, authenticity, integrity and confidentiality of stored or transmitted personal

For these purposes, the Controller plans procedures for the management of personal data breaches.

What happens if you do not provide your details?

Please read the consequences of disabling cookies, as shown in the table above.

How

Data processing is performed through IT procedures by internally specifically authorised and trained individuals. These individuals can access your personal data to the extent to and within the limits in which it is necessary for the performance of the processing activities that concern you. Your data are processed separately from others also by means of pseudonymisation or aggregation methods that do not allow you to be easily identified.

The Controller periodically checks the equipment through which your data are processed and the security measures provided for them which are constantly updated; it verifies, also by the persons in charge of the processing, that no personal data are collected, processed, filed or stored the processing of which is not necessary; it verifies that the data are kept with the guarantee of integrity and authenticity and that they are used for the purposes of the processing actually performed.

Where

The data are stored in computerised and electronic files located within the European economic area.

For how long

What are your rights?

In essence you can, at any time, free of charge and without any specific conditions and formalities for your request:

- obtain confirmation of the processing performed by the Controller;
- access your personal data and know their origin (when data are not obtained from you directly), the purposes and scope of the processing, the data of the parties to whom they are communicated, the retention period of your data or the criteria useful to determine it;
- update or rectify your personal data so that they are always exact and
- erase your personal data from the databases and/or archives including backup of the Controller in the event, inter alia, where they are no longer necessary for the purposes of the processing or if this is assumed to be illicit, and if the conditions required by law are met; and however if the processing is not justified by another equally legitimate reason;
- limit the processing of your personal data in certain circumstances, for example where you have disputed their accuracy, for the period necessary for the Data Controller to verify such accuracy. You must be informed, in reasonable time, even when the suspension period has been completed or the cause of the limitation of processing no longer exists, and therefore the limitation itself is withdrawn;
- obtain your personal data, if received or processed by the Data Controller with your consent and/or if their processing is done on the basis of a contract and with automated equipment, in electronic format also in order to transmit them to another data controller.

The Data Controller must do so without delay and, however, no later than one month after receiving your request. The deadline may be extended by two months if necessary, taking into account the complexity and the number of requests received by the Controller. In such cases, the Controller will inform you within one month of receiving your request and shall provide you with the reasons for the extension.

How and when can you object to the processing of your personal data?
